Financial Counseling Certification (FiCEP)

What is FiCEP?

In its tenth year, The Wisconsin Credit Union Foundation has partnered with America's Credit Unions and CU Difference to bring financial counselor training to credit union professionals and volunteers through the Financial Counseling Certification Program (FiCEP). Enhanced FiCEP is designed for people who work in the member service, collections, and lending departments, as well as any other staff that are committed to helping members gain control of their financial future.

This program is modeled after America's Credit Unions' Certified Financial Counselor School and includes nine educational webinars and an in-person session where students will take their exam and learn ways to make financial counseling more effective at their credit union.

Once the student has passed their proctored, 100 question examination at the in-person session, they will then have earned the designation of CCUFC, Certified Credit Union Financial Counselor.
